7. REVIEW & APPROVAL OF MINUTES

- MOTION to approve the June 26, 2025 Council minutes as amended. Moved, seconded and carried
 - Correction in the list of Council members Bill Weber (Ministry & Personnel & Stewardship). Stewardship was taken out.

8. BUSINESS ARISING

- Task Group Recommendations re Postings and Shorelines Respectfully Christine Wilde, Debbie Procter, Mary McFadden, Nancy Knowles, Peter Challen.
 - The team were unable to make a final report at this time but will endeavor to do so for the next Council meeting.
- Harvest Dinner Update Deb thanked Christine for the poster and tickets.
 - Folks from the community have been asking if they can help.
 - It is hoped that each Council member will take home some tickets to sell to friends and neighbours.
 - Tickets will be available at church.
 - Tables of 10 can be reserved if known ahead of time.
 - Aiming for 200 125 sit down and 75 take out.
 - Silent auction for 3-4 baskets of wine. Council members were asked to donate one bottle of wine.
- **9. NEW BUSINESS Deb Gill:** Opened the conversation with the question "Can we, should we pursue these grant opportunities?" Strongly promoting that a Grant Team be developed.
 - Reviewed the immediate available grants:
 - The Community Vibrancy Fund Small Projects will fund up to 50% of eligible project costs to a maximum of \$10,000 in available funding. Matching funds must be cash, no matching of in-kind services. Due Wednesday, October 15, 2025.
 - Conversation was opened with Janice:
 - The main concern is matching the grant funds. Janice gave several examples
 of audio/visual equipment that would enhance both GBP and HSUC. It is felt
 that the Fall concerts will be money makers and the use of sponsorship funds
 was mentioned. Janice is confident that these funds can be matched.
 - MOTION that Grand Bend Place through Huron Shores United Church apply for the Community Vibrance Fund Small Projects grant, matching funds up to \$4,000 from Grand Bend Place. Moved and seconded.
 - Discussion: After Janice emphasized that any enhanced audio/visual item that may be purchased using funds from this grant would be multipurpose and that both GBP and HSUC would benefit. The motion was Carried.
 - Sunset Community (attachment #1) Grants are offered in the following Areas of Interest: Children & Youth, Family & Community, Health & Physical Activity, Education, Social Services & Low Income Impact, Preservation of the Environment, Diversity, Equity, Inclusion & Belonging, Arts & Culture.
 - Applications are accepted online only and must be submitted by midnight on September 30, 2025.

- Conversation was opened with Debbie: Debbie felt that there was not a match for Property needs. The conversation turned to Janice and the grant would be applied under "Arts & Culture."
 - It has been realized that, in general, people do not know where GBP is. It is felt that if lighted signs were to be installed on the building walls one facing Main St. and the other facing Queens Ave., GBP would become much more visible to the public.
 - MOTION that Grand Bend Place apply through Huron Shores United Church to the Sunset Community grant supporting the purchase of two permanent signs. One on the Main St side of the building and the other on Queens Avenue. The wording would be "Huron Shores United Church home of Grand Bend Place - Centre of the Living Arts." Moved and seconded.
 - Discussion GBP will need to get quote and report back to Council.
 Reminded that this is a fully funded grant. The motion was Carried.
- **UCC Grant** recommendation to fund a Communication Working Group. Application due on October 15, 2025.
 - Conversation was opened to Nancy this grant is to concentrate on marketing and promotion, vision and mission. Council agreed that Nancy and Roger should investigate further and bring back what they believe to be appropriate for the next Council meeting.
- **Light Catering Deb Gill:** Explained that there is a need for a group to be organized to handle requests for providing light lunches for gatherings such as funerals, etc. Policies would be put in place and available in a notebook. It is fortunate that Trish Challen has agreed to lead this group. A sincere thanks to Trish was given.
 - MOTION that a group be organized lead by Trish Challen to do light catering such as funerals and celebrations of life at our discretion. Moved, seconded and carried.
- **Permanent/flex stage Karen Etherington:** Further the Worship & Music team report, the Ad Hoc team, after research, will bring back the costs to Council.
 - MOTION that an ad hoc task force be formed to research, over the next 10 months, the possibilities of a portable or permanent accessible stage for the sanctuary. The task force to be comprised of chair of worship, chair of GBP, chair of property, and Dan Gill construction consultant. Recommendation to come back to Council. Moved, seconded and carried.
- Summer Services Deb Gill: More involvement is needed with decision to have or not to have outside service. Recommended change and to involve the COF – perhaps create a Survey Monkey. Worship & Music will take this on.

WORSHIP & MUSIC – Karen Etherington:

Actions completed:

- Summer services July 6 through to August 24 were held drawing upon the musicals and theatre from the Playhouse and Stratford. COF enjoyed special music suppled by guests - Lynne Douglas, Tom Taylor, Rod Culham and Fiona Short.
- Greeters implemented passing of the offering baskets at the summer services.

Actions pending:

- September 7 & 14- to be held in the green cathedral, weather permitting at 10 a.m.
- September 21 & 28- welcome back into the sanctuary at 10 a.m.
- Embellishment will decorate for the theme of "Creation".
- October 26- anniversary Sunday with guest worship leader Mavis Curry.
- HSUC singers to perform a Christmas Cantata "Love" economically sourced/shared from a church in Carmel, California. Details to follow.
- Proposing a motion to ask "that an ad hoc task force be formed to research, over the next 10 months, the possibilities of a portable or permanent accessible stage for the sanctuary. PROPERTY - Debbie Procter:

Actions Completed:

- 519Windows Inc. were contracted to clean all our church windows inside and outside for a cost of \$751.45.
- Two new LED solar lights have been ordered and will be installed on our Community Bulletin Board. The total cost to do this will be \$1717.60. This completes all the requirements for the Sunset Community Foundation Grant.

Actions Pending:

- Brick repair work needs to be done on the east side of the church. This project has been put on hold until funds become available.
- The sidewalk replacement and drainage on the west side of the church requires attention. This will be done once funds become available. An estimate has been obtained to complete this project at \$6,497.50 from D. Gill Construction.
- Quotes for new proper directional signage, to replace the paper laminated signs have been put on hold for now.
- Purchasing a prefabricated shed to accommodate more storage is needed. An 11' x 7' shed is available at Jacobs Liquation Centre, in St. Marys for a cost of \$1850.00 + tax. They will deliver the three large heavy boxes for \$40. The new shed would sit beside the other two sheds at the north end of our property.

Security WG – Dan Gill, Chris Barry, Roger Hyatt and Debbie Procter

Actions Pending:

- The Security WG is developing a guideline to present to Council with regards to upgrading our security systems for all church email accounts. Currently all church email communications are a labyrinth of church and personal email accounts. It is felt by this group that each Council chair should have their own personal account. The separation of personal and church accounts would prevent viruses or malware from cross contamination. This would help with our You Tube login for recording our church services.
- They are also recommending that an external system be implemented to back up all church
 accounts which isn't being done at the present time. A final recommendation will be forthcoming
 from this group soon.

• Maintenance and Repair WG - Chris Barry and Dan G.

 Actions Pending: Coming up with a resolution to fix two of our outdoor watering taps that are leaking.

• Kitchen WG – Lois Gill and Debbie Procter

• Actions Pending: House cleaning of the kitchen and the servery will be completed in the fall.

Green Team WG – Lois Gill and Debbie Procter

Actions Complete:

- The watering of the urns from the rain barrels continues. The rain barrels did have to be refilled with church water once during the summer months due to the lack of rain.
- The church gardens have been tidied up, as a lot of our perennials have died off due to the lack of rain.

Actions Pending:

- The two Maple trees in the Community Living Room are getting large and need to be pruned. The branches are growing into the hydro lines on the Main St. I have contacted All Around the Bend to trim them for us. They can only do it up to a certain height. They recommended we contact Ontario Hydro. This idea will be investigated.
- The west side walkway needs to be power washed.

• Food Pantry Update:

• Actions Pending:

- A new electronic keypad with Wi-Fi capabilities will be installed on the Food Pantry Door. This will allow the Operations Manager to open and close the door remotely. This was approved by the Food Pantry executive at their meeting at a cost of \$900. This expense will come out of the Food Pantry budget.
- A price for the donor recognition sign for the GB Community Food Pantry has been obtained from Track
 21. We received a copy of the proof of the design, and it has been approved. It will be installed once
 Track21 has it completed.
- The cement walkway pad to the northeast leading to the Food Pantry needs to be completed. This will be done soon.
- A new buzzer and light device will be installed outside of the Food Pantry, allowing volunteers to have a warning signal that they can push, if they get into a situation where they need help.
- The Food Pantry executives are planning two fundraising events, one in the fall and one in February 2026. More details to follow.

Parking Update:

- Contact was made with the owner of the plaza building across from the church about using his parking space behind his building for Sundays and GBP concerts. He is more than willing to let us use his space for parking.
- Do we need to continue using the limited mobility signs in the 5 spots to the north of the Queens Ave. walkway?
 - We have not used them all summer. No one has suggested otherwise.
 - They are cumbersome to carry and awkward to put together.
 - During the winter the parking spots get slippery, and it makes it difficult to manage them without worrying about falling.
 - During the winter months we lose two spots due to snow piled up in them.
 - There have been times when there are empty parking spaces available and no one wants to use them. Yet we have other seniors without mobility issues that could use them.
 - There have been times when the pylons have been left out overnight, so when other people arrive at the church in the morning, they do not want to use the parking spaces.
 - One of the volunteers that has been assigned this task in the past has mobility issues. I know they find it difficult to manage the pylons and the posts.

Grand Bend Food Pantry Community Advisory Council Established

After a grand successful opening event in October, the Grand Bend Community Food Pantry is well under way and busier than expected. Now, Huron Shores United Church has created a Community Advisory Council (CAC) to guide its development. Marg Alfieri, a clinical dietitian who also serves as Chair of the Grand Bend Area Community Health Centre (CHC), is leading the new group.

The CAC will report regularly to the Church, which birthed and houses the Pantry, and other partners in the project. Members of the CAC include Pantry volunteers, representatives from the church and other non-profits, and Operations Manager Lois Gill.

Alfieri, a creative and energetic leader, has big plans. She'd like to see a community kitchen and seniors' hub at the church, and hopes to develop closer collaboration with the CHC, the Grand Bend Legion, and other local groups. "The Pantry is part of the community now," she says. "It's about more than just providing food -- it's about building a stronger, more connected community where everyone can thrive."

Alfieri illustrates that point with a story. She met a Pantry client who told her that he had been homeless for 18 months. Thanks to the money he saves by using the Pantry, he is now able to afford a small apartment.

The CAC will also focus on fundraising. "Support has been fantastic to date, the community has been more than generous," says Alfieri. "Now we need a strategy to ensure ongoing support." In addition to personal and corporate contributions, Alfieri is busy applying for grants to support the Pantry and related programming.

"We encourage everyone in the community to visit, volunteer, or donate to the Pantry," she says. "Whether it's a contribution of food, time, or money, every bit counts." Written by the wonderful Pat Morton- a strong supporter of the pantry

Pantry News & Updates

We welcomed new members to our Community Advisory Council who quickly created some new roles and enhanced our operations with innovations. Mary Beth Billick joined as our Scheduling Coordinator and Judi Clark joined as our Volunteer and Training coordinator. We have been working through some quality improvement changes – how to make things easier for our volunteers. We now have a milk man position - this means all milk is purchased once a week by our big strong milk man. Gerry Davidson is our first milk man – always looking for another 'milk man." Our volunteers appreciate not having to buy all the milk. We also added a red wagon to make moving groceries from the cars to the basement stock area and then back out to the pantry much easier on everyone's back. One volunteer laughed and said, "we aren't even close to being 60 anymore!" Our volunteers are our heart and engine, so anything to make their work easier is a very good thing. Sadly, one of our long-term volunteers Yvonne Carroll has moved from Grand Bend to a new chapter in her family's life – so we wish her well. Christine Wilde's job at the church has changed slightly and she is focusing primarily on the Church administrative tasks but remains a pantry volunteer.

Second Harvest

We rescued over \$5.100 worth of food from Sobeys over the past five months. This represents over 900 meals for our neighbours. More than 300 lbs. of meat have been received. Sobey's community spirit is feeding Grand Bend and area residents, who are experiencing food insecurity. The food received is freely shared among the three food security sites – the Main/Queen Street Green Door and the Community Health centre's two sites.
